
[Changes to Title XIII: Student Government Association Agencies]


.01 **WHEREAS**, The Director of Campus Life serves as a voting and debating member of the Board of  
 .02 Student Directors;  
 .03 **WHEREAS**, There is currently no exception to be made in the event that there is no Director of Campus  
 .04 Life;  
 .05 **WHEREAS**, All powers and those powers not specifically granted herein to other branches of Student  
 .06 Government shall be vested in the Student Body President, assisted by the Student Body Vice President,  
 .07 and such other administrative officers as the President shall appoint to effectively carry out the business  
 .08 of Student Government Association; and  
 .09 **WHEREAS**, The Student Body President should be able to appoint a representative to attend the Board  
 .10 of Student Directors meeting, in the absence of the Director of Campus Life;

 .12 **THEREFORE, BE IT**  
 .13 **ENACTED**, by the Forty-Fifth Student Senate of the University of Central Florida that Title XIII be  
 .14 revised in the following ways:

 .16 **1301.4** Board of Student Directors Voting Membership  
 .17 A. All Student Directors are granted voting and debating rights on the Board of Student  
 .18 Directors.  
 .19 B. The Director of Campus Life shall serve as a voting and debating member of the Board  
 .20 of Student Directors.  
 .21 C. In the event a ~~Student Director~~ **member of the Board of Student Directors** cannot attend  
 .22 a board meeting, the Student Director shall appoint, in writing to the Chair, a designee to  
 .23 the Board of Student Directors.  
 .24 **D. In the event that the Director of Campus Life position is vacant, the Student Body**  
 .25 **President shall appoint, in writing to the Chair, a designee to the Board of Student**  
 .26 **Directors.**
