
.01 **WHEREAS**, Counselor Education Doctoral Students Organization (CEDSO) has been a Registered Student Organization  
 .02 since 2008;  
 .03 **WHEREAS**, The mission of the Counselor Education Doctoral Students Organization is to promote the development of  
 .04 Counselor Education Students in the areas of scholarship, teaching, and service through mentoring and collaboration  
 .05 opportunities;  
 .06 **WHEREAS**, CEDSO currently has 23 active, dues-paying members;  
 .07 **WHEREAS**, CEDSO members pay dues of \$15.00 per year;  
 .08 **WHEREAS**, CEDSO assists counselor education doctoral students through mentorship and volunteer work and encourages  
 .09 research and scholarship at local, national, and international conferences;  
 .10 **WHEREAS**, The Association of Counselor Education and Supervision (ACES) allows doctoral students to submit scholarly  
 .11 presentations and network with the national counselor education community;  
 .12 **WHEREAS**, CEDSO members will be able to explore trends and get research mentorship in current areas of counselor  
 .13 education and supervision;  
 .14 **WHEREAS**, CEDSO members will be staying at the Hyatt Regency at the Colorado Convention Center in Denver, CO; and  
 .15 **WHEREAS**, Counselor Education Doctoral Students Organization received \$0.00 in the 2013-2014 Activity and Service Fee  
 .16 Budget;


.18 **THEREFORE, BE IT**  
 .19 **ENACTED**, by the Forty-Fifth Student Senate of the University of Central Florida that \$8,390.00 be allocated to Counselor  
 .20 Education Doctoral Students Organization from the Registration and Travel Account (7140-0007) according to the following  
 .21 breakdown:
