[Funding for 10 members of Trial Team to attend the University of Georgia's Classic City Invitational Tournament in Atlanta, GA, from October 18-20, 2013]


- .01 WHEREAS, Trial Team has been a Registered Student Organization since 1998;
- .02 WHEREAS, The mission of Trial Team is to provide insight into the litigation process for all members; to strengthen its
- .03 members oral and written communication skills as they relate to the litigation process; to expose students to the trial process to
- .04 better prepare them for law school and a possible career in litigation;
- .05 WHEREAS, Trial Team has 30 active, dues-paying members;
- .06 WHEREAS, Trial Team new members pay \$150.00 in dues per year, returning members pay \$100.00 in dues per year, and
- .07 non-competing members pay \$75.00 in dues per year;
- .08 WHEREAS, Trial Team plans to attend multiple competitions during the fall semester, where it will represent the University
- .09 of Central Florida in the legal, litigation, and pre-law communities;
- .10 WHEREAS, Trial Team fundraises through membership dues, copayments for tournaments, car washes, silent auctions, and
- .11 sponsorships from law firms, friends, and family;
- .12 WHEREAS, Trial Team is hosting the 2014 National Tournament in Orlando, Florida;
- .13 WHEREAS, The purpose of these events is to give litigation experience to Trial Team members, make them more
- .14 competitive for law school, and allow them to network with professionals in the legal profession;
- .15 WHEREAS, Trial Team members will be renting minivans from Avis Car Rental;
- .16 WHEREAS, Trial Team members will be lodging at the DoubleTree Hotel in Atlanta, GA; and
- .17 WHEREAS, Trial Team received \$0.00 in the 2013-2014 Activity and Service Fee Budget;

 .20 **ENACTED**, by the Forty-Fifth Student Senate of the University of Central Florida that \$1,386.00 be allocated to Trial Team
 .21 from the Registration and Travel Account (7140-0007) according to the following breakdown:


