- .01 WHEREAS, John T. Washington Honor Society (JTWS) has been a Registered Student Organization since 1996;
- .02 WHEREAS, The mission of John T. Washington Honor Society is to uphold the principles of leadership, scholarship, and
- .03 service in which JTWS was founded upon. To uphold the legacy of the late Dr. John T. Washington, we seek to question,
- .04 evaluate, and raise the standard for the multicultural descent student by creating an atmosphere containing ideas, insight, and
- .05 support, we seek to foster the desire to succeed at the University of Central Florida and throughout life;
- .06 WHEREAS, JTWS members pay dues of \$15.00 annually for returning members, and \$30.00 annually for new members;
- .07 WHEREAS, JTWS currently has 35 active, dues-paying members;
- .08 WHEREAS, The National Black Student Leadership Conference provides pathways to leadership and development for college
- .09 students to impact their success in a multi-dimensional environment;
- .10 WHEREAS, JTWS is attending this conference to provide the scholars the knowledge and resources to improve their overall
- .11 personal, professional, and leadership development;
- .12 WHEREAS, Those attending will be able to share those leadership strategies learned at the conference with others in the UCF

 .19 **ENACTED**, by the Forty-Sixth Student Senate of the University of Central Florida that \$2,640.00 be allocated to John T.




