- .01 **WHEREAS**, Phi Alpha Delta has been a Registered Student Organization since 1992;
- .02 **WHEREAS**, The mission of Phi Alpha Delta is to be a professional law fraternity advancing integrity, compassion and courage through service to the student, the school, the profession and the community;
- .03 **WHEREAS**, Phi Alpha Delta members pay dues of \$140.00 for the first semester and \$50.00 for every following semester;
- .04 **WHEREAS**, Phi Alpha Delta has 120 active, dues-paying members;
- .05 **WHEREAS**, The Phi Alpha Delta Pre-Law Conference will provide members the opportunity to visit the nation's capital while gaining knowledge about law schools and its process, as well as speaking and networking with law school admission representatives;
- .06 **WHEREAS**, Phi Alpha Delta will be lodging at the Hyatt Regency Crystal City in Arlington, VA; and
- .07 **WHEREAS**, Phi Alpha Delta received \$0.00 in the 2014-2015 Activity and Service Fee Budget;


.11 **THEREFORE, BE IT**



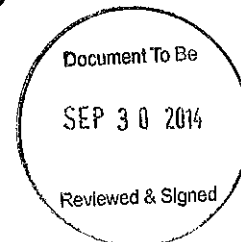

- .24 **BE IT FURTHER ENACTED**, That no funds be spent on Bus;

- .26 **BE IT FURTHER ENACTED**, That Phi Alpha Delta completes a post-travel form and returns it to the Operations Review Committee (ORC) by December 15, 2014, as a condition of receiving funding.
