[Updates to Title III: The Legislative Branch clarifying the rules and restrictions of ORC Representatives]

.01 **WHEREAS**, Statutes are in constant need of revision to reflect implementation and procedure;
 .02 **WHEREAS**, The current statutes regarding ORC Representatives are vague and inconsistent; and
 .03 **WHEREAS**, The unclear nature of these statutes can currently lead to the possession of too much influence in the hands of an individual;
 .04
 .05 **THEREFORE, BE IT**
 .06 **ENACTED**, by the Forty-Sixth Student Senate of the University of Central Florida that the following changes be made to Title III: The
 .07 Legislative Branch:

Chapter 308 Senate Committee Membership

 .11 308.1 No Senate committee's membership shall exceed ten Senators, with exception of CRT and FAO, as described
 .12 in Chapter 307.
 .13
 .14 308.2 The FAO, LJR, and CRT committee membership shall be elected from within the Senate
 .15 A. Senators may be voting members of either the CRT Committee or the FAO Committee, but not both.
 .16 B. The CRT Committee and the FAO Committee shall be allotted an additional seat, which is reserved for an ORC
 .17 representative.
 .18 C. An ORC representative, as ~~voted on~~ **elected** by the ~~ORC Operations Review~~ **Committee**, shall sit as a voting member on
 .19 the FAO Committee and the CRT Committee. ~~The same ORC Representative may not sit as a voting member on both the~~
 .20 ~~CRT and FAO Committees. The same individual may not be elected as ORC representative to both CRT and FAO~~
 .21 ~~Committees.~~
 .22 D. Acting as ORC Representative on either the CRT or FAO Committee shall not count towards that Senator's two Standing
 .23 Committee memberships. **An individual elected as ORC representative may not also sit on a fiscal committee.**
 .24 E. In the absence of an ORC representative from CRT or FAO Committee meeting, the ORC Chair or ORC Vice Chair shall
 .25 be able to attend ~~in the ORC representative's absence~~ **as a non-voting member.**

 .27 308.3 If the FAO committee or CRT committee membership falls below the maximum number of members, the
 .28 Senate, by a majority vote, may decide to hold an election to fill the vacant committee seats. To be elected to
 .29 the committee, those nominated shall only require a majority vote.
 .30
 .31 308.4 LJR Committee Membership
 .32 A. If the committee membership falls below the maximum number of members, the Senate, by a majority vote, may decide
 .33 to hold an election to fill the vacant committee seats. To be elected to the committee, those nominated shall only require
 .34 a majority vote.
 .35 B. No new senators may be elected to the LJR committee once an Impeachment affidavit has been filed. This prohibition
 .36 shall last until the Removal Hearing has concluded or the affidavit is dismissed.
 .37
 .38 308.5 The Senate President Pro Tempore or their designee shall be a member of every Senate Committee.
 .39 A. Their membership shall not count against quorum; however, it shall count for it.
 .40 B. Their membership shall not count as one of the ten members that all committees are limited to.


