[Updates to Title II: Student Government Statutory Definitions and Parliamentary Authority changes to Statutory Definitions]

- .01 **WHEREAS**, Statutes are in constant need of revision to best reflect policy and serve the Student Body;  
.02 **WHEREAS**, Current statutes have resulted in confusion regarding terminology and intent of definitions;  
.03 **WHEREAS**, Revision of these statutes will ensure consistency and clarity of terminology within the Constitution of  
.04 the Student Body of the University of Central Florida, Student Body Statutes, and Senate Rules and Procedures; and  
.05  
.06 **THEREFORE, BE IT**  
.07 **ENACTED**, by the Forty-Sixth Student Senate of the University of Central Florida that the following changes be made to  
.08 Title II: Student Government Statutory Definitions and Parliamentary Authority:  
.09  
.10 **Chapter 201 Statutory Definitions**  
.11  
.12 **No-Confidence** - Lack or absence of confidence in a leader within the Senate an **Officer of the Student**  
.13 **Senate.**  
.14  
.15 **Property** - All physical and electronic materials that are in any way managed by the Student Government  
.16 Association or are purchased or maintained through the Activity and Service Fee (**A&SF**).  
.17  
.18 **Student Government Agent**—Any student position that is specifically stated in the Student Body Statutes (e.g.,  
.19 President, Vice President, Judicial Council Member, Senator), that holds the position of Student Director of an Agency,  
.20 or is compensated through the Activity & Service Fee Budget Other Personnel Service (OPS) line-item of:  
.21 A. Student Government: Executive  
.22 B. Student Government: Legislative  
.23 C. Student Government: Judicial  
.24 D. Student Government: Election Commission  
.25 E. Student Government: Southern Region Campus  
.26 F. Student Government: Eastern Region Campus  
.27 G. Student Government: A&SF Committee  
.28  
.29 **Student Government Agent** - Any student position that falls under at least one of the following categories:  
.30 A. Specifically stated in the Student Body Statutes (President, Vice President, Judicial Council Member,  
.31 Senator, etc.)  
.32 B. Holds the position of Student Director of an Agency  
.33 C. Is compensated through the Activity & Service Fee Budget Other Personnel Service (OPS) line-item of:  
.34 1. Student Government: Executive  
.35 2. Student Government: Legislative  
.36 3. Student Government: Judicial  
.37 4. Student Government: Election Commission  
.38 5. Student Government: A&SF Committee  
.39  
.40 **Student Government Association Affiliated Services**—An Activity and Service Fee entity of the Student Government  
.41 Association, adopted and/or created to provide campus activities, student support, education, and leadership opportunities  
.42 and/or created to maintain Activity and Service Fee funded facilities.  
.43 A. Any Student Government Association Affiliated Service that is primarily run by a Student Director under the  
.44 supervision of an A&SF funded staff advisor shall be known as a “Student Government Association Affiliated Service.”  
.45 B. Any Student Government Association Affiliated Service that is primarily run by an Administrative Director shall be

.46 known as a "Student Government Association Affiliated Department."

.48 **Student Government Association Affiliated Agencies - An A&SF entity of the Student Government Association,**  
.49 **primarily run by a Student Director under the supervision of an A&SF funded staff advisor, that is adopted**  
.50 **and/or created to:**


A. Provide campus activities, student support, education, and leadership opportunities

.53 **Student Government Association Affiliated Departments - An A&SF entity of the Student Government**  
.54 **Association, primarily run by an Administrative Director, that is adopted and/or created to:**

A. Provide campus activities, student support, education, and leadership opportunities; and/or

B. Created to maintain Activity and Service Fee funded facilities


