- .01 **WHEREAS**, Gospel and Cultural Choir (GCC) has been a Registered Student Organization since 1979;
- .02 **WHEREAS**, The mission of GCC is to is to come together in Christian fellowship to minister to the people of God through

- .04 **WHEREAS**, GCC Members pay dues of \$20.00 annually or \$10.00 per semester;
- .05 **WHEREAS**, GCC currently has 40 active dues-paying members;
- .06 **WHEREAS**, The Gospel and Cultural Choir Tour will allow members to come together as a choir and give students a chance to
- .07 minister to communities that they have never been to before;
- .08 **WHEREAS**, GCC members will be attending a graduate information session at New York University;
- .09 **WHEREAS**, GCC members will be attending a workshop with the New York University Gospel Choir;
- .10 **WHEREAS**, GCC members will be able to utilize skills learned during the tour at future performances in the University of
- .11 Central Florida (UCF) area;
- .12 **WHEREAS**, GCC will be lodging at the Best Western Plus Richmond Airport Hotel in Sandston, VA, Hampton Inn-Waldorf
- .13 in Waldorf, MD, Extended Stay America in Bethpage, NY, and Best Western in Long Island City, NY; and
- .14 **WHEREAS**, Gospel and Cultural Choir received \$0.00 in the 2014-2015 Activity and Service Fee Budget;

THEREFORE, BE IT

ENACTED, by the Forty-Seventh Student Senate of the University of Central Florida that \$7,778.34 be allocated to Gospel and Cultural Choir from the Registration and Travel Account according to the following breakdown:

Bus	(1 week rental)	\$11,440.00

Total Gospel and Cultural Choir Contribution		\$9,506.86
Total Senate Contribution		\$7,778.34

BE IT FURTHER ENACTED, That all unspent funds revert back to their originating account by April 17, 2015; and
BE IT FURTHER ENACTED, That Gospel and Cultural Choir completes a Post-Funding Form and returns it to the Operations Review Committee (ORC) by April 17, 2015, as a condition of receiving funding.

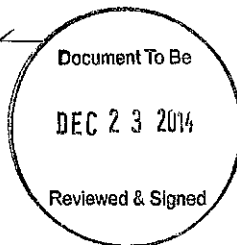
