- .01 **WHEREAS**, Chabad Jewish Student Group has been a Registered Student Organization since 2007;
- .02 **WHEREAS**, Chabad Jewish Student Group's mission is to provide activities that enable UCF students to practice and explore
- .03 Judaism and Jewish tradition;
- .04 **WHEREAS**, Chabad Jewish Student Group focuses on traditional Jewish values through the perspective of Chasidic
- .05 philosophy;
- .06 **WHEREAS**, Chabad Jewish Student Group has 800 active student members;
- .07 **WHEREAS**, Chabad Jewish Student Group provides a traditional atmosphere for students to pray, practice their worship, and
- .08 embrace their culture;
- .09 **WHEREAS**, Rosh Hashanah is the Jewish New Year;
- .10 **WHEREAS**, Yom Kippur is the Jewish Day of Atonement in which people all over the world pray and fast;
- .11 **WHEREAS**, Chabad Jewish Student Group provides a traditional atmosphere for people to pray;
- .12 **WHEREAS**, Chabad Jewish Student Group has previously had over 300 students attend High Holy Days services each night;
- .13 **WHEREAS**, Chabad Jewish Student Group will host High Holiday Services at Central Florida Chabad; and
- .14 **WHEREAS**, Chabad Jewish Student Group received \$0.00 in Activity and Service Fee Funds during the 2015-2016 Fiscal
- .15 Year;

THEREFORE, BE IT

.18 **ENACTED**, by the Forty-Seventh Student Senate of the University of Central Florida that \$7,375.00 be allocated to Chabad

.19 Jewish Student Group from the Senate Working Fund according to the following breakdown:

.31 **BE IT FURTHER ENACTED**, That all unspent funds revert back to their originating account by October 23, 2015; and

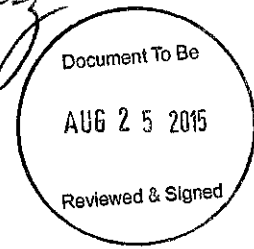
.32 **BE IT FURTHER ENACTED**, That Chabad Jewish Student Group completes a Post-Funding Form and returns it to the
