- .01 **WHEREAS**, Financial Management Association (FMA) has been a Registered Student Organization since 1997;
- .02 **WHEREAS**, FMA's mission is to assist its members preparing for possible future employment opportunities, providing
- .03 guidance for students in course selection, broadening student's knowledge of careers available in the finance field, and
- .04 encouraging interaction between UCF students and business leaders;
- .05 **WHEREAS**, FMA has 100 active, dues-paying members;
- .06 **WHEREAS**, FMA members pay dues of \$75.00 annually;
- .07 **WHEREAS**, At the Clute Institute International Business Conference, members gain valuable information concerning the
- .08 global economy, global markets, and latest academic research on various business and economics-related topics;
- .09 **WHEREAS**, FMA holds weekly meetings, open to all University of Central Florida (UCF) students, to present information and
- .10 knowledge gained from the conference;
- .11 **WHEREAS**, FMA will be lodging at the Monte Carlo in Las Vegas, NV; and
- .12 **WHEREAS**, Financial Management Association received \$0.00 in Activity and Service Fee Funds during the 2015-2016 Fiscal

.15 **THEREFORE, BE IT**

.16 **ENACTED**, by the Forty-Seventh Student Senate of the University of Central Florida that \$16,999.30 be allocated to Financial Management Association from the Registration and Travel Account according to the following breakdown:

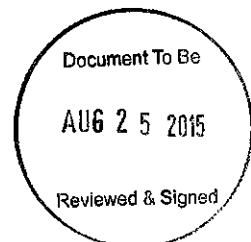

.23	Hotel (\$194.88 per night x 5 nights x 10 rooms)	\$9,744.00
.24	Transportation Orlando (\$325.00 x 2 bus trips)	\$650.00
.25	Transportation Las Vegas (\$110.00 x 2 bus trips)	\$220.00
.26	Total Cost	\$33,998.60
.27	Total Financial Management Association Contribution	\$16,999.30
.28	Total Senate Contribution	\$16,999.30

- .30 **BE IT FURTHER ENACTED**, That no funds be spent on Transportation Orlando, Transportation Las Vegas, and Deposit;
- .31 **BE IT FURTHER ENACTED**, That all unspent funds revert back to their originating account by November 16, 2015; and
- .32 **BE IT FURTHER ENACTED**, That Financial Management Association completes a Post-Funding Form and returns it to the
- .33 Operations Review Committee (ORC) by November 23, 2015, as a condition of receiving funding.
