[Funding for Chabad Jewish Student Group to host Shabbat 1,000 on April 1, 2016 in the Student Union Pegasus Grand Ballroom]

.01 WHEREAS, Chabad Jewish Student Group has been a Registered Student Organization since 2007;
 .02 WHEREAS, Chabad Jewish Student Group's mission is to provide activities that enable UCF students to practice and explore
 .03 Judaism and Jewish tradition;
 .04 WHEREAS, Chabad Jewish Student Group focuses on traditional Jewish values through the perspective of Chasidic
 .05 philosophy;
 .06 WHEREAS, Chabad Jewish Student Group has 700 active members;
 .07 WHEREAS, Chabad Jewish Student Group provides a traditional atmosphere for students to pray, practice their worship, and
 .08 embrace their culture;
 .09 WHEREAS, Shabbat 1,000 is an event in which students will gather for Shabbat dinner;
 .10 WHEREAS, Shabbat 1,000 will raise awareness of Jewish life on campus;
 .11 WHEREAS, Last year Shabbat 770 had over 700 students attend the event;
 .12 WHEREAS, Cultural food consists of but is not limited to challah, matzah ball soup, chicken, and grape juice;
 .13 WHEREAS, Chabad Jewish Student Group has previously had over 250 students attend Shabbat services and dinner;
 .14 WHEREAS, Chabad Jewish Student Group will host Shabbat 1,000 in the Student Union Pegasus Grand Ballroom at
 .15 University of Central Florida (UCF); and
 .16 WHEREAS, Chabad Jewish Student Group received \$7,255.00 via Senate Bill 47-87, \$7,375.00 via Senate Bill 47-88,
 .17 \$1,000.00 via FAO Allocation 47-127, \$1,000.00 via FAO Allocation 47-175, \$1,000.00 via FAO Allocation 48-53 in Activity
 .18 and Service Fee Funds during the 2015-2016 Fiscal Year;

 .20 **THEREFORE, BE IT**
 .21 **ENACTED**, by the Forty-Eighth Student Senate of the University of Central Florida that \$6,825.00 be allocated to Chabad
 .22 Jewish Student Group from the Senate Working Fund according to the following breakdown:

 .36 **BE IT FURTHER ENACTED**, That Chabad Jewish Student Group completes a Post-Funding Form and returns it to the
 .37 Operations Review Committee (ORC) by May 9, 2016, as a condition of receiving funding.
