[Updates to Title III — The Legislative Branch]


1 WHEREAS, Statutes require constant updates and revision to best serve the Student Body;  
 2 WHEREAS, This Bill will go into effect immediately;

 4 **THEREFORE, BE IT ENACTED**, by the Forty-Ninth Student Senate of the University of Central Florida that  
 5 Title III, 304.7 be amended as follows:

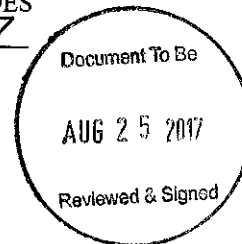

 7 304.7 Powers and Duties of a Deputy Pro Tempore

- 8 A. Shall attend all meetings of special, standing, and ad hoc committees as designated by the
- 9 Senate President Pro Tempore.
- 10 B. Shall not occupy any Committee Chair throughout his or her term of office.
- 11 C. Shall have respective titles of Deputy Pro Tempore of Senate Operations and
- 12 Appropriations or Deputy Pro Tempore of Legislative Affairs as designated by the Senate
- 13 President Pro Tempore.
- 14 D. Must meet on a weekly basis with the Senate President Pro Tempore
- 15 E. Must attend all Senate, Student Government, or assigned Committee meetings in the place
- 16 of the Senate President Pro Tempore.
- 17 F. Must take accurate minutes of business conducted in the Senate Executive meetings in
- '8 the absence of the Senate President Pro Tempore.
- 19 G. Be responsible for having an updated copy of *Student Body Statutes* and *Senate Rules* at
- 20 every standing or ad hoc meeting held in compliance with Florida Sunshine Laws.
- 21 H. In absence of the Senate President Pro Tempore, shall have full voting and debating
- 22 privileges in assigned committees.
- 23 I. Shall approve with the concurrence of the **Senate** President Pro Tempore, all Senate
- 24 Committee meetings to which they are assigned.
- 25 J. In the case of the absence of the Senate President Pro Tempore, the internal line of
- 26 authority is designated first to the Deputy President Pro Tempore of Senate Operations
- 27 and Appropriations and then to the Deputy Pro Tempore of Legislative Affairs as
- 28 "Acting" **Senate** President Pro Tempore.
- 29 K. In the case of the resignation, removal, or succession of the **Senate** President Pro
- 30 Tempore, the Deputy President Pro Tempore for Senate Operations and Appropriations
- 31 shall assume the position as "Acting" **Senate** President Pro Tempore until such time as
- 32 an election is held.
