[Funding for 35 members of Chabad Jewish Student Group to attend the International Shabbaton & Leadership Conference in New York City, NY from November 2-5, 2017]


- .01 WHEREAS, Chabad Jewish Student Group has been a Registered Student Organization since 2007;
- .02 WHEREAS, The mission of Chabad Jewish Student Group is to provide activities that enable UCF students to practice and
- .03 explore Judaism and Jewish tradition;
- .04 WHEREAS, Chabad Jewish Student Group focuses on traditional Jewish values through the perspective of Chasidic philosophy;
- .05 WHEREAS, Chabad Jewish Student Group currently has 1,000 active members;
- .06 WHEREAS, Chabad Jewish Student Group provides an orthodox atmosphere for students to pray, practice their worship, and
- .07 embrace their culture;
- .08 WHEREAS, The purpose of Shabbaton & Leadership Conference is to enhance Jewish Leadership Development and Training;
- .09 WHEREAS, The Shabbaton & Leadership Conference will host a variety of speakers and events that will teach the attendees to
- .10 become better Jewish leaders; and
- .11 WHEREAS, Chabad Jewish Student Group received \$1,000 via FAO Committee Allocation 49-135 in Activity and Service Fee
- .12 Funds in the 2017-2018 Fiscal Year;

 .14 **THEREFORE, BE IT ENACTED**, by the Forty-Ninth Student Senate of the University of Central Florida that \$6,755.00 be  
 .15 allocated to Chabad Jewish Student Group from the Senate Working Fund according to the following breakdown:



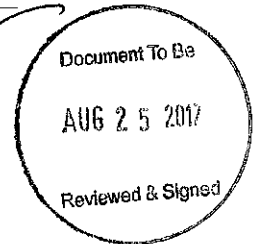
- .24 **BE IT FURTHER ENACTED**, That all unspent funds revert to their originating account by December 5, 2017; and
