

[Funding for 12 members of the United Nations Association to travel to the McGill Model United Nations in Montreal, Quebec, Canada, from January 25-28, 2018]


- 1 **WHEREAS**, The United Nations Association (UNA) has been a Registered Student Organization since 1997;
- 2 **WHEREAS**, The mission of UNA is to provide a forum to study and promote the fundamental basis of peace with
- 3 justice, to encourage participation in the United Nations and other official international and regional organizations,
- 4 and to promote the ideals of international cooperation;
- 5 **WHEREAS**, UNA members pay dues of \$45.00 annually or \$25.00 a semester;
- 6 **WHEREAS**, UNA currently has 38 active, dues-paying members;
- 7 **WHEREAS**, The purpose of the McGill Model United Nations is to compete in Model United Nations, develop
- 8 diplomacy and public speaking skills, and interact with delegates from all over the world;
- 9 **WHEREAS**, The United Nations Association will be engaging in debate and conversations on international issues
- 10 and expanding the influence of UCF abroad;
- 11 **WHEREAS**, All of the delegates will be more versed in diplomacy and negotiating, and winning awards at the
- 12 conference will increase the UCF MUN team's national ranking;
- 13 **WHEREAS**, UNA will be lodging at the Le Centre Sheraton in Montreal, Quebec, Canada; and
- 14 **WHEREAS**, United Nations Association received \$3,000.00 via CRT Allocation 50-35 in Activity and Service Fee
- 15 Funds in the 2017-2018 Fiscal Year;

- 17 **THEREFORE, BE IT ENACTED**, by the Fiftieth Student Senate of the University of Central Florida that
- 18 \$4,405.71 be allocated to United Nations Association from the Registration and Travel Account according to the
- 19 following breakdown:

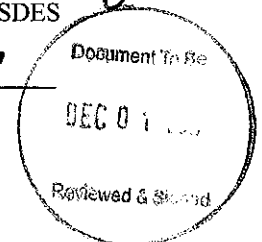

- 30 **BE IT FURTHER ENACTED**, That United Nations Association completes a Post-Funding Form and returns it to
- 31 the Operations Review Committee (ORC) by March 5, 2018, as a condition of receiving funding; and
- 32 **BE IT FURTHER ENACTED**, That United Nations Association completes a Verification of RSO Purchases Form
- 33 by March 5, 2018, as a condition of receiving funding.
