- 1 **WHEREAS**, Real Estate Academic Leaders has been a Registered Student Organization since 2007;
- 2 **WHEREAS**, The mission of Real Estate Academic Leaders is for students interested in the field of real estate and its
- 3 diverse and cumbersome range of issues;
- 4 **WHEREAS**, Real Estate Academic Leaders members pay dues of \$40.00 pe semester;
- 5 **WHEREAS**, Real Estate Academic Leaders currently has 20 active dues-paying members;
- 6 **WHEREAS**, The purpose of the ICSC RECon is to teach the art of commercial real estate deal making;
- 7 **WHEREAS**, Members will network with professionals in the industry and seek jobs/internships;
- 8 **WHEREAS**, Real Estate Academic Leaders will be lodging at the MGM Grand Las Vegas in Las Vegas, Nevada;

- 29 Form by July 2, 2018, as a condition of receiving funding.

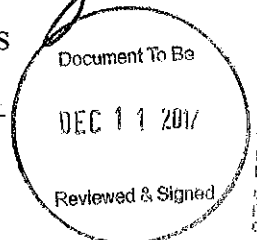
