[Funding for Chabad Jewish Student Group to host the Passover 2018 at Chabad at UCF, on March 30, 2018-April 1, 2018]

1 **WHEREAS**, Chabad Jewish Student Group (CJSG) has been a Registered Student Organization since 2007;
 2 **WHEREAS**, The mission of CJSG is to provide activities so that UCF students may practice and explore
 3 Judaism and Jewish tradition;
 4 **WHEREAS**, CJSG focuses on traditional Jewish values through the perspective of Chasidic philosophy;
 5 **WHEREAS**, CJSG currently has 1,000 active members;
 6 **WHEREAS**, The purpose of the Passover 2018 is to create cultural awareness and diversity on campus;
 7 **WHEREAS**, The event will give students the opportunity to celebrate Passover and learn about Jewish culture and
 8 celebration;
 9 **WHEREAS**, CJSG has hosted this event for 11 years with 500 student attendees;
 10 **WHEREAS**, CJSG received \$1,000.00 via FAO Allocation 49-135 and \$1,000.00 via FAO Allocation 50-010;

 12 **THEREFORE, BE IT ENACTED**, by the Fiftieth Student Senate of the University of Central Florida that \$9,500.00
 13 be allocated to Chabad Jewish Student Group from the Senate Working Fund according to the following breakdown:

25 **BE IT FURTHER ENACTED**, That all unspent funds revert to their originating account by May 1, 2018;
 26 **BE IT FURTHER ENACTED**, That Chabad Jewish Student Group completes a Post-Funding Form and returns it to
 27 the Operations Review Committee (ORC) by May 7, 2018, as a condition of receiving funding; and
 28 **BE IT FURTHER ENACTED**, That Chabad Jewish Student Group completes a Verification of RSO Purchases
 29 Form by May 7, 2018, as a condition of receiving funding.
