2 Association Combined Sections Meeting 2019 in Washington, D.C. on January 23, 2019 - January 27, 2019]

4 **WHEREAS**, Student Physical Therapy Association has been a Registered Student Organization since 1995;

5 **WHEREAS**, The mission of the Student Physical Therapy Association is to promote the awareness of the physical
6 therapy program on the campus and in the community, facilitate the growth and wellness of physical therapy
7 students, and provide volunteer services throughout the community thereby furthering continuing education of
8 physical therapy students.;

9 **WHEREAS**, Student Physical Therapy Association members pay dues of \$25.00 annually;

10 **WHEREAS**, Student Physical Therapy Association currently has 74 active, dues-paying members;

11 **WHEREAS**, The purpose of this conference is to serve as the national conference of the American Physical Therapy
12 Association (APTA) that represents all sections and specialties of the physical therapy profession. At CSM, attendees
13 have the opportunity to attend educational sessions from all areas of physical therapy specialty, listen to and/or
14 present research posters or platforms (if accepted), and network with other physical therapists, students, and
15 employers within the physical therapy community;

16 **WHEREAS**, By attending CSM 2019, students will have the opportunity to: 1) build upon their educational
17 endeavors within physical therapy by attending educational sessions and research presentations, 2) network with
18 other PT students, physical therapists from multiple specialties, potential employers, APTA leaders, and policy
19 makers 3) build their professional development skills through career exploration. Additionally, 14 members of SPTA
20 have been accepted to present their research in a poster or platform format to other professionals of the physical
21 therapy profession. These opportunities bring awareness to the caliber of research produced within UCF's Doctor of
22 Physical Therapy program;

23 **WHEREAS**, Students will bring back this valuable knowledge and experience to UCF students and to develop more
24 and more of our students professionally;

25 **WHEREAS**, Student Physical Therapy Association will be lodging at the Hyatt Place Washington DC/White House
26 in Washington, D.C.; and

27 **WHEREAS**, Student Physical Therapy Association received \$0.00 via FAO/CRT Allocation in Activity and Service
28 Fee Funds in the 2018- 2019 Fiscal Year;

30 **THEREFORE, BE IT ENACTED**, by the Fifty-First Student Senate of the University of Central Florida that
31 \$15,220.17 be allocated to Student Physical Therapy Association from the Registration and Travel Account
32 according to the following breakdown:





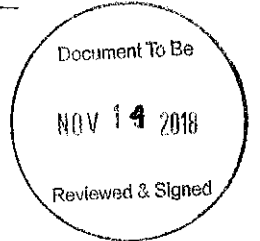
