





**Resolution 47-02**

[Updated 2014-2015 CRT Committee Spending Policy]

.01 **WHEREAS**, Title VIII: The Finance Code states that the Conference Registration and Travel (CRT) Committee must introduce legislation  
 .02 establishing the current year's Registration and Travel Account Spending Policy;  
 .03 **WHEREAS**, The CRT Committee has reviewed prior Spending Policies;  
 .04 **WHEREAS**, The CRT Committee feels that it is in the best interest of the student body to continue this statute-mandate requirement;  
 .05  
 .06 **THEREFORE, BE IT**  
 .07 **RESOLVED**, by the Forty-Seventh Student Senate of the University of Central Florida that the following policies be established for use of the  
 .08 Registration and Travel account by the CRT Committee and the Senate:  
 .09       1. Allocation requests must be time-stamped and received by the CRT Chair prior to the start of the CRT meeting for  
 .10       them to be considered.  
 .11       2. Allocation requests must be heard by the CRT Committee at least fourteen (14) business days before funding is  
 .12       needed.  
 .13       3. The funding level for Senate Bills shall be 50% of total costs, unless the amount of eligible expenses is less, or the  
 .14       entity requests a lower funding level.  
 .15       4. The only exception to the above stated funding level shall be sanctions imposed by the Operations Review  
 .16       Committee, or the organization reaching the total funding limit.  
 .17       5. If an organization is requesting funding, an authorized officer of the organization must be present at the CRT  
 .18       Committee, Caucus, or Senate meeting to be considered.  
 .19       6. Regional Campus, Rosen, and Medical School students may be present via teleconference and/or video conference.  
 .20       7. If an individual cannot make CRT committee meeting, CRT Caucus, or Senate meeting due to extenuating  
 .21       circumstances, said student may be present via teleconference and/or video conference. At the discretion of the CRT  
 .22       committee, they may also be represented by another student who is going on the same conference as the individual or  
 .23       a designated representative.  
 .24       8. Internships, study abroad trips, retreats, and similar trips at the discretion of the CRT Committee will not be  
 .25       eligible to receive funding from CRT.  
 .26       9. The Registration and Travel Account will not be used to fund costs outside the realms of registration, lodging, and  
 .27       primary mode of transportation.  
 .28  
 .29 **BE IT FURTHER RESOLVED**, That to break this policy, it will take a two-thirds (2/3) vote of the CRT Committee or the Student Senate.
