[Changes to Rule One: The Senate Executive Committee]

- 1 **WHEREAS**, Rule One has many technical and formatting errors;
2 **WHEREAS**, Rule One has redundancies that are expressed elsewhere in Senate Rules;
3 **WHEREAS**, Rule One gives the opportunity of multiple voting powers to one member; and
4 **WHEREAS**, This Resolution will take effect immediately;

6 **THEREFORE, BE IT RESOLVED**, by the Fiftieth Student Body Senate of the University of Central Florida
7 that Senate Rule One be updated as follows:

9 **1.01 ~~Senate Executive Committee~~ COMPOSITION OF THE SENATE EXECUTIVE COMMITTEE**

10 **The Senate Executive Committee shall be comprised of**

- 11 **A. The Senate President, who shall serve as Chair;**
12 **B. The President Pro Tempore, who shall serve as Vice Chair;**
13 **C. The Deputies Pro Tempore;**
14 **D. The Legislative Assistants;**
15 **E. Standing and Ad Hoc Committee Chairs; and**
16 **F. Standing and Ad Hoc Committee Vice Chairs.**

17 ~~A. Members: The Senate Executive Committee shall be comprised of the Senate President Pro~~
18 ~~Tempore, the Deputy Pro Tempore of Senate Operations and Appropriations, the Deputy Pro~~
19 ~~Tempore of Legislative Affairs, the External Legislative Assistant, the Internal Legislative~~
20 ~~Assistant, the standing and ad hoc Committee Chairs, the Vice Chairs, and the Speaker of the~~
21 ~~Senate, as an ex-officio member.~~

22 ~~1. All standing committee and ad hoc committee Chairs shall have voting and debating~~
23 ~~powers.~~

24 ~~2. The Senate President Pro Tempore shall have all voting and debating privileges.~~

25 ~~3. Vice Chairs shall have all debating Privileges and, in the absence of the Chair, then the~~
26 ~~Vice Chairs shall have privileges of voting.~~

27 ~~4. The Deputy Pro Tempore of Senate Operations and Appropriations and the Deputy Pro~~
28 ~~Tempore of Legislative Affairs shall have all debating privileges and, in the absence of~~
29 ~~the Pro Tempore, The Deputy Pro Tempore of Senate Operations and Appropriations~~
30 ~~shall have voting privileges. If the Deputy Pro Tempore of Senate Operations and~~
31 ~~Appropriations is also absent, the Deputy Pro Tempore of Legislative Affairs will have~~

33 ~~5. The Legislative Assistants shall have all debating privileges.~~

34 ~~B. The Speaker of the Senate shall be the Chair, the Senate President Pro Tempore shall be the Vice~~

36 ~~C. The Senate Executive Committee shall meet, as called by the Speaker of the Senate, the Senate~~

39 **1.02 POWERS OF SENATE EXECUTIVE COMMITTEE MEMBERS**

- 40 **A. The Deputies Pro Tempore shall have debating powers.**
- 41 **B. The Legislative Assistants shall have debating powers.**
- 42 **C. Standing and Ad Hoc Committee Chairs shall have voting and debating powers.**
- 43 **D. Standing and Ad Hoc Committee Vice Chairs shall have debating powers.**

45 Voting powers shall be restricted to count as one vote if a Senate Executive Committee member
46 holds more than one membership in the committee.

48 **1.03 ROLES AND RESPONSIBILITIES OF THE SENATE EXECUTIVE COMMITTEE**


49 The Senate Executive Committee shall

- 50 **A. Conduct meetings as called by Senate President, the Senate President Pro Tempore, or**
- 51 **majority vote of the Senate Executive Committee.**
- 52 **B. Represent the Student Body Senate in times of crisis.**
- 53 **C. Present and argue the views of the Student Body Senate, as expressed by Resolutions.**
- 54 **D. Facilitate communication between the officers of the Student Body Senate.**
- 55 **E. Serve as an appellate avenue for Senate business, as provided by the *Senate Rules*.**

56 ~~1.2 Roles and Responsibilities of the Senate Executive Committee:~~

- 57 ~~A. To represent the Student Senate in "times of crisis" and to present and argue the views of the~~
- 58 ~~Senate, as expressed by Senate resolutions.~~
- 59 ~~B. To facilitate communication between the officers of the Student Senate.~~
- 60 ~~C. To serve as an appellate avenue for Senate business, as provided for in the Senate Rules and~~
- 61 ~~Procedures.~~
- 62 ~~D. To expunge Senate meeting absences of Senate members, upon petition of the Senator in question,~~
- 63 ~~by majority vote of the Senate Executive Committee.~~
